

Amendment No. 1 TO THE AGREEMENT BETWEEN COUNTY OF LAKE - LAKE COUNTY BEHAVIORAL HEALTH SERVICES AS LEAD AGENCY FOR THE LAKE COUNTY CONTINUUM OF CARE AND SOCIAL SOLUTIONS GLOBAL, INC. FOR THE SERVICE AND COORDINATION OF ACTIVITIES INVOLVED WITH THE LAKE COUNTY CONTINUUM OF CARE HOMELESS MANAGEMENT INTEGRATION SYSTEM SOFTWARE FOR FISCAL YEARS 2021-2022, 2022-2023 AND 2023-2024.

This Amendment No 1 to Agreement is made and entered into this 1st day of January, 2021 by and between the County of Lake, a political subdivision of the State of California (hereinafter referred to as "County"), Lake County Behavioral Health Services (hereinafter referred to as "LCBHS") as lead agency for Lake County Continuum of Care (hereinafter referred to as "LCCoC") and Social Solutions Global, Inc. (hereinafter referred to as "SSG" or "Contractor"), collectively referred to as the "parties."

RECITALS

WHEREAS, the parties hereto have entered into an Agreement dated August 1, 2020 under which contractor will provide coordination and activities involved with the LCCoC Homeless Management Integration System software; and

WHEREAS, the parties now desire to amend that agreement to allow for additional compensation to be paid for additional deliverables in the form of ten (10) additional user licenses in addition to the thirty five (35) user licenses included in the original contract; and

NOW, THEREFORE, the parties hereto agree to the following Amendment to the Agreement:

3. **COMPENSATION**. Contractor has been selected by County to provide the services described hereunder in Exhibit A, attached hereto. County agrees to pay Contractor Forty Six Thousand Six Hundred Dollars (\$46,600.00) for remainder of Fiscal Year 2020-21 and Fiscal Year 2021-2022, Thirty Four Thousand Six Hundred Dollars (\$34,600.00) for Fiscal Year 2022-23 and Thirty Four Thousand Six Hundred Dollars (\$34,600.00) for Fiscal Year 2023-24, and an additional One Hundred Thirty Seven Thousand Six Hundred Seventy Dollars (\$137,670.00) for Ten (10) additional user client licenses for the contract term for a total 3-year contract maximum of Two Hundred Fifty Three Thousand Four Hundred Seventy Dollars (\$253,470.00).


