**WHEREAS.** the parties now wish to amend that agreement to allow for additional compensation to contractor for provided services during fiscal year 2020-21; and

**NOW, THEREFORE,** the parties hereto agree to the following amendment to the Agreement:

**3. COMPENSATION.** Compensation to Contractor, originally listed as not to exceed Two Hundred Thirty Four Thousand Five Hundred and Fifty Dollars (\$234,550.00) shall now read as not to exceed Three Hundred Seventy Six Thousand Eight Hundred Thirty Four Dollars and Seventy Three Cents (\$376,834.73).
